Coordinator for Community Engagement

The main task of the position is, to function as a link between turtle conservation and the needs of the local people of Boa Vista. This includes to implement and oversee our ongoing community engagement-plan, to coordinate events and to start a new recycling project.

Background

Our main cooperation partners are the two other 3 NGOs working in the conservation of sea turtles on Boa Vista (Cabo Verde Natura 2000 and Bios.CV), and the Ministry of Agriculture and Environment. We also maintain close collaboration with other public entities, among them the Municipality of Boa Vista, the National Police on Boa Vista Island and several community associations.

Our program started in 2009 and is ongoing. Besides the protection and data collection of loggerhead sea turtles on their nesting beaches, it focused on three areas of intervention, which are habitat protection, contribution to protected area management and community engagement.

In order to implement a sustainable approach where local communities benefit from sea turtle conservation, we are looking for an experienced community worker, who will lead the community engagement part of our program on Boa Vista.

- ✓ Implement the activities defined in the work plan according to the budgets
- ✓ Adjust the work plan and schedule the subsequent activities to be undertaken in cooperation with the supervisors

This position requires an assertive and independent individual with excellent communication skills, good organizational skills, sound judgment, initiative and flexibility.
